PLAYSPORTS is a Sports and Physical Education program for children ages 2-10

- Our coaches teach your children a variety of Ball and Sports skills appropriate to you child's age.
- **Classes have a maximum of 8 children per class**
- We supply all the equipment that is age appropriate and safe.
- *Many young children have not yet decided which sport they enjoy the most, so we expose them to 9 sports. The sports are Baseball, Soccer, Basketball, Tennis, Golf, Football, Lacrosse, Volleyball and Hockey.*
- The **2 and 3 year olds** learn basic ball skills and movement activities. A big emphasis is placed on Following Instructions, Listening and Sharing.
- The **4 to 6 year olds** learn Basic and more Complex skills of the different sports. They are introduced to game situations in gentle, fun and non competitive way. A big emphasis is placed on Sportsmanship, Cooperation, Following directions, Communication and Self Esteem.
- **Children receive a progress report each month.**

Fees are due on the 1st of the month. There will be a \$10 late fee if received after the 10th unless prior arrangement has been made.

I will give you written notice at the end of the month if my child is not continuing with the Program. If this is not done, it will be assumed that my child is continuing in the next month, and I'm responsible for the full fees for the next month.

I freely agree to allow PLAYSPORTS to use my child's photograph and/or video for advertising and promotional purposes, including the website, only without compensation to my child or myself. No last names will be used in any promotional materials.

I freely allow Playsports to include my child in any Playsports Team photo that may be taken.
